Prof. HeeSun Chung is a distinguished professor at the forensic science department of Sungkyunkwan University, Korea. Prof. Chung is a Fellow in the AAFS Toxicology Section. She served as the 13th President for the International Association of Forensic Toxicologists (TIAFT) from 2014 to 2017 and the 22nd president of The International Association of Forensic Sciences (IAFS) from 2011 to 2014.

Co-moderator Dr. Simon Elliott. Dr. Simon has extensive experience in clinical and forensic toxicology. He is a Consultant Forensic Toxicologist, Director of Elliott Forensic Consulting Ltd and Toxicology UK Ltd, and a Visiting Professor in Forensic Toxicology at King's College London. Dr. Elliott is an advisor to the WHO and UNODC and has published many papers concerning "NPS," New Psychoactive Substances.

Speakers:

Dr. Justice Tettey holds the degrees of Doctor of Philosophy in Pharmaceutical Sciences (University of Strathclyde, Scotland) and Doctor of Laws (*honoris causa*, University of Dundee, Scotland). He is the Chief of the Laboratory and Scientific Service of the United Nations Office on Drugs and Crime (UNODC) and responsible for the implementation of the Office's scientific and forensic program, including oversight of the UNODC Early Warning Advisory (EWA) on New Psychoactive Substances (NPS). The UNODC EWA currently monitors over 1000 NPS worldwide and supports international policy decisions on these substances.

Dr. Barry K. Logan is Sr. V/P and Chief Scientist of Forensic Sciences at NMS Labs. He is also Executive Director at the non-profit Center for Forensic Science Research and Education (CFSRE) at the Fredric Rieders Family Foundation in Willow Grove, Pennsylvania. Dr. Logan is a Fellow of the American Board of Forensic Toxicologists (ABFT) and Executive Director of the Robert F. Borkenstein course at Indiana University. Dr. Logan has received numerous national and international awards and served as President of the American Academy of Forensic Sciences (AAFS) in 2013-14.

Michael Evans-Brown specializes in early warning, risk assessment, and public health responses to emerging drug threats. Since 2012, he has worked at the European Monitoring Centre for Drugs and Drug Addiction (EMCDDA). He is the program manager for risk assessment and risk communication of new psychoactive substances. Before joining the EMCDDA, he worked as a senior researcher in emerging drugs issues, focusing on human enhancement drugs in society. Michael was also responsible for coordinating the United Kingdom's early warning system on new psychoactive substances.

Dr. Dimitri Gerostamoulos is Head of Forensic Science and Chief Toxicologist at the Victorian Institute of Forensic Medicine, Melbourne, Australia. He has 30-years' experience in forensic toxicology and has published numerous scientific papers. He is an approved assessor for the National Association of Testing Authorities, Australia (NATA) in Forensic Science.
